

- Serve on the Endowment Committee
- Serve on the Salary Review Committee
- See that all meetings are conducted in an orderly fashion
- Countersign all checks issued

VICE PRESIDENT OF THE CONGREGATION

Term of Office: Two years as Vice-President, followed by two years as President

Responsibilities:

- Perform all duties of the President in his absence, his disability, or at his request
- Attend all meetings of the Church Council and Voters' Assembly
- Serve on the Endowment Committee
- Serve on the Finance Committee
- Serve on the Salary Review Committee

RECORDING SECRETARY

Term of Office: Two years (limit of three, 2-year terms in succession)

Responsibilities:

- Attend to any correspondence, record resolutions, minutes, and take attendance of the Church Council and the Voters' Assembly meetings
- Serve on the Endowment Committee
- Serve on the Salary Review Committee

TREASURER

Term of Office: Two years (limit of three, 2-year terms in succession)

Responsibilities:

- Attend all meetings of the Church Council and Voters' Assembly
- Present a monthly report of all funds received and disbursed, as provided by the Business Manager
- Serve on the Endowment Committee
- Serve on the Finance Committee
- Serve on the Salary Review Committee
- Countersign all checks issued

Executive Board Members -

Wayne Ahlbrecht, President Bill Brickzen, Vice-President Joyce Aul, Recording Secretary Mary Lemke, Treasurer The Executive Board along with the Church Council members (one member from each board), meets monthly. Meetings include reviewing statistics, financial reports, meeting minutes and reports from the various boards and committees and setting the overall budget. Other topics included:

- Constitution updated and work concluded, now called "Articles of incorporation"
- Church Roof Leaking Issues evaluating best plan to more forward
- New Website for church & school launched Mar 2021
- Approving fund releases/Special Donations & Memorials

- Street Improvement City project completed payoff of entire project (\$108,680.25).
- Due to Covid-19, many in-person studies and activities were affected. Adult Bible Study resumed 1/17/21, Confirmation classes resumed 1/20/21, and Sunday School resumed 2/7/21
- Nicole Ahlbrecht-Becker concluded a Financial Audit Report. All accounting and processes are accurate and efficient
- Paycheck Protection Program monies of \$164,000 received – this was a forgivable CARES ACT grant
- Received McLeod Cares \$ monies \$15,234 for FLC and \$6921 for FLS
- Received SBA \$10,000 Grant put in General Fund
- FLS qualified for EANS reimbursements of up to \$85,829
 expenses will be submitted as they are incurred
- New Employee Manual written and approved

Board of Deacons

Term of Office: Two years (limit of three, 2-year terms in succession)

Purpose: Assist the pastors in maintaining proper decorum during worship services, assist the pastors in the work of church discipline, and make decisions for the spiritual life of the congregation.

Responsibilities:

- Attend monthly meetings of the Board; one member to attend monthly church council meetings
- Work at worship services on a rotating basis assisting with ushering, offerings, and Communion distribution
- Concern for the spiritual well-being of church members
- Review the needs, salary, and performance of the Pastoral staff, Music Staff, and the DCE
- Prepare and submit an annual Board of Deacons budget
- (2) Members to serve on Salary Review Committee

The Board of Deacons consists of 10 members who meet monthly. The Deacons are aided by 13 Elders who assist with ushering, offering collection, and other responsibilities as needed. Meetings include reviewing unfinished and new business, Pastors reports, statistics for attendance and communion, financial reports, reports from Church Council, Technology, Assimilation, and Committee representatives, and setting the overall annual Board of Deacons budget.

- Overview of Medical procedures & AED instructions

Elders

These are positions that assist the Deacons at all worship services. Elders serve a 1-year term and are not eligible to vote. They are asked to attend quarterly meetings for roster scheduling. Responsibilities include: ushering, collecting offerings, communion, and assisting Deacons. It is optimum to have (13) Elder positions that can be scheduled to serve every 3-4 weeks.

Ushers

These are volunteer positions needed at all worship services.
Responsibilities include: collecting offerings, ushering pews for communion, attendance counting, etc. We welcome new ushers of all ages and are in need of ushers and captains! Please contact the church office to volunteer!

Board of Stewardship

Term of Office: Two years (limit of three, 2-year terms in succession)

Purpose: Initiate programs for the development of good stewardship for the congregation and to ensure the financial stability of the congregation through regular, proportionate, first-fruit giving.

Responsibilities:

- Attend monthly meetings of the Board, one member to attend church council meetings
- Provide for the training and utilization of the congregation for the work of Christ's Kingdom
- Prepare and submit an annual Board of Stewardship budget

The Board of Stewardship consists of a minimum of 5 members who meet monthly. Meetings include reviewing statistics, financial reports, and setting the overall annual Board of Stewardship budget.

- Promoting Time, Talent, and Treasure to energize the congregation
- Review On-line Giving
- Present messages at worship services and in bulletins
- Select & promote quarterly recipients for Angel Seeds McLeod Emergency Food Shelf, Adopt a Student – Concordia Seminary Fort Wayne, Blizzard Blast, Mayer Lutheran High School
- Giving Tuesday 12/1/20 Christmas cards sent to our member shut-ins (156) and McLeod County veterans (241). (13) Volunteers

- Discussions regarding a BBQ fundralser or Raffle fundralser have been discontinued

- Financial Peace University classes set for Sept Nov,

Cemetery Board

Term of Office: Three years (limit of two, 3-year terms in succession)

Purpose: Maintain the cemetery property and to manage the investment of the perpetual care fund.

Responsibilities:

- Attend quarterly meetings of the Board
- Oversee, as directed, under the Constitution of the Lutheran Cemetery Association

Board of Trustees

Term of Office: Two years (limit of three, 2-year terms in succession)

Purpose: Supervise the property of the congregation (Church & School), the financial transactions and to oversee the buildings, maintenance, and the work of the office staff.

Responsibilities:

- Attend monthly meetings of the Board, one member to attend church council meetings
- Oversee the maintenance and improvements of all properties
- Fill necessary custodial and office positions
- Review the salary and performance of the custodial and office staff
- Prepare and submit an annual Board of Trustees budget
- Chairperson to countersign all checks issued in the absence of President/Treasurer
- (2) Members to serve on Salary Review Committee

The Board of Trustees consists of a minimum of 7 members who, along with the Business Manager and Custodian, meet monthly. Meetings include reviewing statistics, financial reports, and setting the overall annual Board of Trustees budget.

Board of Evangelism

Term of Office: Two years (limit of three, 2-year terms in succession)

Purpose: Promote awareness of, and interest in, the Gospel message, and First Lutheran Church via Public Relations, organize programs for identifying and evangelizing prospective members (outreach), help new members get acquainted so that they enter the active mainstreaming of congregational life (Integrations: help members get better acquainted with each other and with new members, fostering an atmosphere of unity, mutual concern, and fellowship support).

Responsibilities:

- Attend monthly meetings of the board, one member to attend church council meetings
- Conduct programs to meet the above purposes, organize the greeter programs, the visitor program, plan new member welcome events, evangelism training, and other fellowship events
- Prepare and submit an annual Board of Evangelism budget

The Board of Evangelism consists of a minimum of five members who meet monthly. Meetings include reviewing statistics, financial reports, and setting the overall annual Board of Evangelism budget.

This is a volunteer committee who help to assimilate new members into our congregation.

Purpose: To provide for a welcoming transition into our congregation for all new members (via adult confirmation or transfer).

Day School Board

Term of Office: Two years (limit of three, 2-year terms in succession)

Purpose: Cooperate with the principal in the supervision of the total program of Christian Education in the Day School.

Responsibilities:

- Attend monthly meetings of the board, one member to attend church council meetings
- Supervise teachers and students
- Fill teaching positions with qualified individuals
- Make and implement policies and fee schedules
- Review the salary and performance of the teaching staff
- Prepare and submit an annual Day School Board budget
- (2) Members to serve on Salary Review Committee

The Day School Board consists of a minimum of five members who, along with the Day School principal, meet monthly.

Meetings include principal's report, review and approval of school expenditures, reviewing statistics, financial reports, and setting the overall annual Day School Board budget.

- 2020/2021 FLS enrollment was 132 students (81 families) for Pre-K to 8th Grade (FLC members 88 students/50 families and non-members 44 students/31 families).
- ◆ In-person Learning was held the entire 2020-2021 School Year -Much planning /preparedness due to Covid
- <u>Day School</u> tultion for the upcoming 2021/2022 year was set for members at \$1400 (1st child), \$1200 (2nd child), \$1000 (3nd child), and \$850 (4th child). Day School tultion was set for non-members at \$2625 (1st child), \$2250 (2nd child), \$1850 (3nd child), and \$1000 (4th child). Any sister LCMS congregations (without a day school) or members of St. Plus X Church in Glencoe receive a 25%

discount. All first-time families (kindergarten and transfer) receive a 10% discount. Tuition Aid, Free-Reduced Lunches, and Scholarships may be available.

- FL offers \$200 to any school or church family that successfully refers a child to FLS.
- The board approved housing allowances for teachers and approved the new school calendar.
- Ali-Day Preschool (began Fall 2018). School hours are 8:00 a.m. until 3:00 pm. Parents have a variety of options to choose; from half days/partial week, to full days/complete week. Tuition rates range from \$625 to \$2200. Eligible children must be age 3 and 4 (by Sept 1). All community children are welcome to attend. Other topics included:

Other ongoing fundraisers include: Coborn's More Rewards, Amazon Smile Program, Country Hearth Labels, and Box Tops for Education.

Flames of Faith Kids Club / Sub-Committee of Day School Board

The Flames of Faith Kids Club serves children (Age 5 - 6th grade) before school from 6:30-7:45 am and after school until 6:00 pm. Note that this is open to all community children. Director, Nancy Ahlers, is with the children after school and Michelle Alsleben is the morning care giver. Twenty-eight children were enrolled in 2020/2021. Fees for 2021/2022 will be \$8 per day for mornings and \$10 per day after school. Both morning and afternoon tuition is \$15 daily.

This program welcomes donations including: healthy, low-sugar snacks, low-sugar drink or drink mixes, Clorox wipes, small paper cups, gently-used board games, Legos, colored chalk, markers, watercolor paint, 13-gallon garbage bags, and Coborn's, Cashwise, or Aldi's gift cards.

Term of Office: Two years (limit of three, 2-year terms in succession)

Purpose: Work with the DCE and pastors in the supervision of the total program of Christian Education within the parish – in the Confirmation program, Sunday School, Adult Bible Study, Vacation Bible School, and others.

Responsibilities:

- Attend monthly meetings of the Board, one member to attend church council meetings
- Encourage effective Christian education programs for youth and adults
- Make and implement policies
- Prepare and submit a Christian Ed/Youth Board annual budget

The Board of Christian Education consists of a minimum of 7 members who along with the DCE (Director of Christian Education) meet monthly. Meetings include reviewing statistics, financial reports, and setting the overall annual Board of Christian Education/Youth budget. Goals for the year include strengthening the Sunday School program, develop a VBS manual, develop a Christian Education Board Policy Manual, and a NYG Info packet.

Sunday School Classes

2's Together with Jesus – Together with Jesus for two-year-old children and their parents is a Sunday School class to help the families know that their church welcomes them. Parents and children meet together for an exciting hour every Sunday (during the school year) to play and learn many things. We learn about and worship God, our Creator, Provider and Savior at a young age level. The class also teaches parents about how to help teach Bible lessons and about the faith of the young one. During the Sunday Worship Services, a *Children's Sermon* is held for our young Christians. Prior to the main sermon the youngsters are invited to come to the front of church for a short sermon and prayer.

Technology Committee

This is a volunteer committee with five to seven members who meet as needed to discuss technological needs of the congregation, such as the recording of church services/messages for local cable TV, radio, and Facebook broadcasts. The committee also oversees the electronic equipment in the church such as for the sound system. Volunteers are utilized for recording the services.

Screens Committee

The Screens Committee designs the screens used for church services and is responsible for training volunteer individuals to run the screens during the services. The Senior pastor approves the screens before service presentation.

Endowment Committee

This Committee consists of the Executive Board, the Business Manager and two members-at-large who meet quarterly. It was established in 2001.

Purpose: Encourage members and friends of First Ev. Lutheran Church to make lasting gifts and bequests that will continue to serve long after the gift is made.

During 2020-2021, earnings on investments were distributed as directed by the Endowment Committee and/or Bequest Guidelines. Compassionate contributors play a key role in the support of our ministries. God has blessed us, and we are very grateful. Monthly newsletter submissions include a variety of ideas on the many ways you can make charitable gifts to FL ministries. Early Childhood Committee / ECC Financing Sub-Committee

This was an appointed committee with six members. It began meeting in 2014 with the Purpose to research and formulate plans for an Early Childhood Center managed by First Lutheran in Glencoe and to pursue the feasibility of funding the Center. The committee worked with Perspectives Consulting Group Inc. to review the 2016 Market Demand Study. Work then proceeded on a Business Plan. Plans are currently on hold. If/when updates become available, the congregation will be informed.

Constitution Committee

Seven members meet, as necessary, to clarify any church constitution verblage. During the past year, the Committee successfully updated our Articles of Incorporation, bringing our Constitution and Bylaws into compliance with the LCMS Minnesota South District and State of Minnesota.

Finance Committee

This is a volunteer committee with appointed members, along with the Vice-President and Treasurer who meet as requested by Business Manager (at present, the plan is to meet quarterly). This committee was originally formed in Nov. 2015.

Purpose: Provide support for the Business Manager, offer ideas to streamline and improve practices, processes, and procedures, help the congregation and boards better understand the finances of the church.

Subjects Included: Developed a historical analysis of FLS costs. In calendar 2020, we had average monthly receipts of \$80,000 and disbursements of \$89,000, resulting in an average monthly deficit of \$9,000. We continue to struggle with how to communicate a clear and easy to understand financial picture to our congregation and how to "engage" our members to attend, participate, and tithe. Statistics and Financials are reviewed.

Nominating Committee

This is an appointed committee with a minimum of seven members who meet as necessary between June and September.

Purpose: Canvas and recruit congregational members to fill the various board openings for the new calendar year.

In 2020, the Nominating Committee worked together in their endeavor to secure candidates for 2021 open positions. A slate of candidates was presented to the Church Council for approval – candidates open for vacancies included: (1) Vice President, (1) Treasurer, (1) Secretary, (3) Board of Deacons members, (14) Elders (Assistant Deacon position that is a 1 yr. term commitment with no voting privileges), (2) Day School Board members, (2) Christian Education Board members, (2) Board of Trustees members, (2) Cemetery Board members, (4) Board of Stewardship members, (2) Board of Evangelism members. The Nominating Committee urges all Boards to reach out to their new members prior to office installation — to help familiarize them. The Nominating Committee is currently working on filling 2022 Board positions.

Salary Review Committee

This Committee consists of the Executive Board, (2) Deacons, (2) Trustees and (2) Day School Board members. No employee or family member of an employee should serve on the Salary Review Committee. In case of conflict, the President will appoint a person.

Purpose: The Salary Review Committee shall consult annually concerning the salaries and benefits of the workers. The Committee shall then bring its findings and recommendations before the Church Council, to be presented to the congregation at the time the Annual Budget is presented.

This committee meets in July/August to discuss the full-time employee benefits through Concordia Plan Services. A choice of (2) Health Plan benefits are offered for the 2020 calendar year: Healthy Me A and Choice 3000. The FL benefit will be \$740 toward the cost of the premium, leaving any balance for the employee. If the premium is less than \$700, the difference will be placed in an HSA account for the employee.

This committee normally meets again in Spring to set any pay raises for full-time employees before the budget process begins. In May 2021, the Voters approved a 2% increase to base wages and step increases for education and experience multipliers.

Thrivent Congregational Advocates

This group consists of eight Thrivent members (Linda Becker, Cindy Eggersgluess, Neil Eggersgluess, Charles Jensen, Verna Kunkel, Harold Kunkel, Pastor Ron Mathison, and Amy Welch) who inform and promote Thrivent programs that benefit First Ev. Lutheran Church and School. (Thrivent's mission is to guide Christians to be wise with money so they can live more content, confident, and generous lives.) First Lutheran Thrivent members are encouraged to utilize the Choice \$ program (in 2020, \$11,339 was directed to our church and school) and the Action Team program (all Thrivent members can lead two action teams per year and receive \$250 seed money for their service activity or fundraiser). The annual Twins game outing was not held due to

Covid-19. It's wonderful that FL increasingly utilized the Action Team program as more than 30 Action Teams were used this past year!

Mary Martha Altar Guild

The Mary Martha Altar Guild members oversee caring for the church chancel and preparing it for services throughout the year. They follow the church calendar by vesting the altar with the proper altar linens and caring for all furnishings of the sanctuary. The Altar Guild carries out its work under the supervision of the Pastors and Deacons.

This past year, the Altar Guild held regular meetings on the second Monday of the month beginning in September through March. Because of the Covid-19 restrictions at the time, when members did not feel comfortable attending meetings, summaries of meetings and happenings were mailed or emailed to members. In the Fall of 2021, we will be looking to change our by-laws to include "any communicant member of First Ev. Lutheran Church of Giencoe, MN shall be eligible for membership." No meetings are held in June, July, or August. Starting in the Fall of 2021, we will meet four times from September through May. Members can give free-will offerings at each meeting. Additional donations are gratefully accepted from memorials and other gifts.

Altar Guild members do special decorating at Thanksgiving, Christmas, and Easter. Because of Covid-19, the Altar Guild members did not serve fellowship time this year but look forward to again serving in the near future.

The Altar Guild currently has 32 members and 10 associate members. New Altar Guild members are always welcome. You sign up to volunteer to work one month a year with two other Altar Guild members. You can join anytime and conveniently help others from the comfort of your home — you need only a phone or a computer! Participation as a prayer chain member is simple, but so very powerful! The Bible says in Phil 4:6 — But in everything by prayer and supplication, with thanksgiving, let your request be made known unto God. Thank you to all our current members for their commitment to prayer — to confidentiality, discretion, and listening to the Holy Spirit.

Members are asked to......pray for our pastors, teachers, staff, and board members; those listed in the church builetin with prayer requests; all congregational members that they would become alive in Christ, our President and all in authority; those serving in the military; and special prayer requests.

How does it work?

Phone Chain — Simply receive a phone call from another prayer chain member with a request. When you receive that call, write down the prayer request word for word as dictated to you. Pray immediately and then call the next person on your chain passing on the dictated information. If you are unable to reach that person, leave a message relaying the info. Continue phoning on down the list until you reach a person or the end of the chain.

E-Mail Chain — Simply receive the email from the prayer chain leader and pray immediately.

Past Fiscal Year – Review & Thoughts

From Pastor Daniel Welch

In mid-July of 2020, Amy and I hosted the Youth over at our house for an outdoor cookout. It was good to be able be together as a group for the first time in over four months! At the end of August, I also accompanied the youth for an afternoon get-together at the Brian and Jen Goff cabin. Throughout the year I helped lead the youth Bible studies on the 1st and 3rd Sunday evenings of the month.

On August 15th, the LWML hosted an LWML zone-wide and socially distanced event here in the Sanctuary focusing on Missions with speakers Mrs. Mary Kay Mages and Miss Samantha Welch. Mary Kay spoke of her experience serving in Eastern Europe several years ago while Samantha spoke on her first year of mission work at Mission of Christ Network, Stronghold Cambodia in Kampot. At this LWML event I had the opportunity to lead the closing devotion, as well as install the new LWML Zone Officers.

On September 1st, we began a new school year here at First Lutheran. In addition to leading chapel once a month I taught the 7th and 8th grade religion class on Monday, Tuesday, and Thursday mornings. We did an overview of both the Old Testament and New Testament of God's Word. I enjoyed this class very much throughout the whole school year and learned a lot in the process. The students were extremely respectful and many of them showed an eagerness to learn even though It was somewhat early in the morning when we met.

On Wednesday September 9th, we had a parent meeting of all of the Catechism students enrolled in the public-school classes from 5th through 8th grades. They voted overwhelmingly to keep classes on Wednesdays at 3:30 even though at the time there was no in-school classes at the public school on Wednesday. Throughout the school year, I had the opportunity to teach the 8th grade Confirmation class of ten public school students and a class of five from First Lutheran School.

Due to restrictions put in place because of the Coronavirus pandemic, Confirmation of the 2019-2020 8th Grade Confirmation class had to be moved from April 26th to October 25th. Eighteen youths confirmed their faith in Christ on that October morning at the 10:30 service. Social distancing guidelines were strictly followed, and everything turned out very well.

In October and November, I led a six-week New Member class on Monday evenings. We had three new members attend and later publicly confirm their faith in the month of December. We were also blessed to have one of these new members first receive the Sacrament of Holy Baptism also in December.

On Reformation Day, Saturday, October 31st, we had the fourth annual Trunk-or-Treat from 3 to 5 PM. This was a great opportunity for families of the congregation and community to get together. Due to Covid concerns, this was done as a "drive-thru" format rather than "walk-thru" format.

Thankfully, we were able to celebrate our Thanksgiving services at their usual times of 7 PM of "Thanksgiving Eve" and 9 AM on "Thanksgiving Day." They were both well attended.

in December we had some special Sunday morning Bible Studies and midweek worship services under the theme "Prepare the Way of the Lord." On Wednesday, December 2nd we celebrated Holy Communion, and on December 9th we had a slim-downed version of an Advent Choral and Music Concert which included the First Lutheran School Choirs singing via Video. On Wednesday, December 16th, we had a similar style of First Lutheran School Christmas Service via video.

On Christmas Eve and Christmas Day, we were able to celebrate Christmas with our regular, in-person worship services at 2 PM, 5 PM, and 7 PM on Christmas Eve and 9 AM on Christmas morning. The attendance was good considering the social distancing times we have been used to living in.

We had our annual re-organization meeting of the Church Boards on Thursday, January 7th. Also, in January I lead a Sunday morning Bible Study entitled: "Nurturing Your Faith-Called", which focused on the book of Ephesians.

During the Lenten Season in February and March, I led a midweek sermon series on the book of Zecharlah called "Your Kingdom Comel" On Sunday mornings during Adult Bible study, we took a close look at the book of Zecharlah and made some applications to our lives today. It was a tremendous blessing to be able to meet in person this year for Lenten, Holy Week, and Easter Services.

On April 25th at the 10:30 service, we had the Confirmation service for thirteen 8th graders. That and the public review service on the Wednesday prior went very well.

In April our church Business Manager, Debi Ramirez retired. I was part of the selection committee to find a new business manager. We selected Becky Edwards for the position and that meant we also had to begin work on selecting and hiring a new congregation secretary. Brianna Quast was selected, and she began her work in June.

On Wednesday, May 26th, I preached at the Eighth Grade Graduation service and on Friday, May 28th, I led the closing chapei service for the 2020-2021 First Lutheran School year.

On Sunday, June 6th, we had the Baccalaureate service at the 10:30 service where we recognized all those who graduated from high school and post-secondary schools this past year.

On a final note, I would like to thank those of you who remembered me and my family in prayer as I considered the Divine Calls that were issued to me in this past year to serve as Pastor at Holy Cross in St. Cloud and at Peace in Park Falls, Wisconsin. I also am grateful also for the encouraging words that many people shared with us during the deliberation process. I feel very blessed to continue to serve you here at First Ev. 
